

### Afghan asylum-seekers fear return home

Young Afghans comprise the majority of unaccompanied asylum seekers arriving in the UK. The British government, along with other European governments, is said to be considering building a centre in Kabul to send back the many 16-and 17-year-old asylum seekers throughout Europe. With 2011 having the highest rate of civilian casualties in Afghanistan, this risk of deportation is proving increasingly fearful for many young Afghans afraid of the deteriorating security situation in their homeland.

### Survey on the impact of policy changes and cuts on services for asylum seekers and refugees

Employability Forum is running a survey for all organisations who support asylum seekers and refugees. The aim is to identify what the gaps are in support services for refugees and asylum seekers. The data will be used to shape the recommendations the Refugee Integration Working Group (co-chaired by EF) will submit to Ministers. ### **Select Committee report on localism and Government response**

On 9 June 2011, the parliamentary Select Committee on Communities and Local Government published its report on localism, including measures in the Localism Bill. The report states:

- The Government has not produced a compelling vision of what its imagined localist future will look like and the functions and responsibilities of the players within it. Greater clarity and certainty is needed.
- Localism should not be adopted purely as a way to achieve reductions in public sector costs, for it is unclear whether it will be able to deliver this in the short term.
- There is not universal support for the idea that central government should retreat entirely from local affairs, allowing accountability to local people to replace performance monitoring from the centre. In particular, organisations representing vulnerable, marginalised or minority groups argue that these sections of the community need protection that cannot be provided by the current mechanisms of local democratic accountability.

### **Protecting children from domestic violence: children and the law**

26 October 2011, one day course, women only

This one day course will enable you to support survivors of domestic violence by helping you to understand and clarify the complex public and private law that relates to children.

The morning session will investigate the key concept of parental responsibility and then focus on local authority involvement with children in domestic violence cases, explaining care and supervision proceedings, adoption and special guardianship. In the afternoon they will focus on the law on contact and residence, with a focus on the court's approach to domestic violence and child contact. They will then examine the practice and procedure of contact proceedings and clarify the new enforcement procedures brought about by the Children and Adoption Act 2006.

#### **Community Radio Fund**

The Office of Communications (Ofcom) has announced that the next round for funding applications for the Community Radio Fund will open on the 19 October 2011. The Community Radio Fund has been established to help fund the core costs of running a community radio station. These not-for-profit radio stations have a social purpose, and work to involve their target community in running the service. Under the fund, Community Radio Stations are being invited to apply for funding to support their core running costs.

There is no upper limit of grant that can be applied for. Grants can only be made to community radio licensees ("Licensee") which are broadcasting under a community radio licence (and not an RSL, for example). Grants awarded usually range from £5,000 to £17,000.

#### **Community First Programme now open!**

Managed by the Community Development Foundation, Community First is an £80m government-funded programme that will run for four years, until March 2015. It will help communities come together through new and existing community groups, to identify their strengths and local priorities, plan for their future and become more resilient.

There are two parts to Community First:

- £30m will be available as small grants in the most deprived parts of the country.
- Up to £50m will be used to match local and national contributions from other sources to provide a national endowment providing longer term sustainable funding for communities.

This fund is for groups working in the south west of England to deliver activities that support those furthest removed from the labour market to move towards employment, education, and volunteering. The fund is specifically targeted at small community groups. Grants up to £12,000 will be available although it is envisaged that most grants will be in the region of £6,000 to £8,000.
