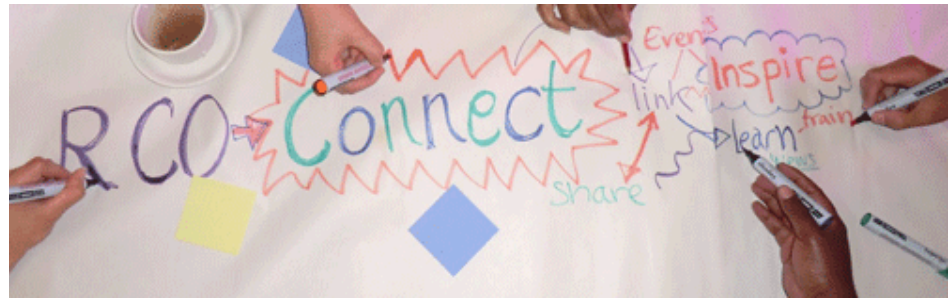

#### 250 delegates come together for Basis Project National Conference

The Basis Project conference on 24 January 2012 saw around 250 delegates from RCOs, funders and second tier organisations come together to look at practical ways forward for refugee community organisations. #### Communities secretary to intervene in Nottinghamshire voluntary sector cuts

Thirdsector magazine reported this week that the communities secretary, Eric Pickles has agreed to intervene in the case of Nottinghamshire County Council over its disproportionate funding cuts to the voluntary sector, according to the National Council for Voluntary Organisations.

The Conservative-led council has cut its voluntary sector grants budget for 2011/12 by about 34 per cent, compared with a cut of about 8 per cent in its grant from central government. [Statutory guidance](#) published by the Communities and Local Government department in September said local authorities should not make "disproportionate" funding cuts to the voluntary sector.

#### MPs attack private security guard immigration removals

According to a report by MPs, private security guards employed to forcibly remove people from the UK have used racist language and inappropriate force. The Commons' Home Affairs Committee said the UK Border Agency should challenge unacceptable behaviour by some of its contractors. The report comes 15 months after a deportee died on a flight. Jimmy Mubenga, 46, fell ill and collapsed on a British Airways plane bound for Angola on 12 October 2010.

The MPs did not comment on the case, which is still being investigated by the police, but said that Mr Mubenga's death had triggered their own investigations into the way that the UK Border Agency managed the

deportation of people on flights from the UK.

### **The Henry Smith Charity - Holiday Grants for Children, UK**

The Henry Smith Charity make grants to organisations and charities throughout the UK for initiatives and projects that address social inequality and economic disadvantage. Applications can be made for their Holiday Grants for Children towards holidays or outings within the UK for children aged 13 and under who are from areas of high deprivation, are experiencing disadvantage, or those who have a disability.

Applications can be considered for holidays or outings that have the objective of providing children with a break they would not otherwise have the opportunity to experience. Holidays or outings can be to countryside or city locations, but must be outside the children's immediate locality.

Schools, youth groups, not for profit organisations and charities are all eligible to apply. The maximum grant available is £3,000 for any one trip. [Click here](#) for more information.
